
For July – September 2019, a total of 432 hand hygiene observations were submitted for analysis and hand hygiene compliance was 98%.

For the analysis of corporate audits, the following definition of hand hygiene was used:

- Compliant:
 - 1) Person was not observed with artificial nails/nail polish or jewellery not approved
- Non-compliant:
 - 1) Person was observed with artificial nails/nail polish not allowed, and/or
 - 2) Person was observed with jewellery not allowed

Figure 1: Hand hygiene compliance rates, Corporate Areas, January – September, 2019




Figure 2: Hand hygiene compliance rates, Corporate Areas, January - September, 2019


For July – September 2019, a total of 2,342 hand hygiene observations were submitted for analysis and hand hygiene compliance was 98%.

 - 3) Jewellery, and/or
 - 4) Artificial nails/nail polish

For July – September 2019, a total of 8,262 hand hygiene observations were submitted for analysis and hand hygiene compliance was 86%.

For the analysis of patient care audits, the following definition of hand hygiene was used:

- Compliant:
 - 1) Hand gel or wash, AND
 - 2) A required time component of \geq 15 seconds
- Noncompliant:
 - 1) Gloves only,
 - 2) Missed hand hygiene opportunity,
 - 3) Hand gel or wash with a time component of < 15 seconds,
 - 4) Jewellery, and/or
 - 5) Artificial nails/nail polish




Figure 4: Hand hygiene compliance rates, Patient Care Areas, January - September, 2019




Figure 5: Hand hygiene compliance, by facility, Patient Care Areas, July - September, 2019




Figure 6: Hand hygiene compliance, by Healthcare Worker, Patient Care Areas, July – September, 2019




Figure 7: Hand hygiene compliance, Regina General Hospital, Patient Care Areas, July - September, 2019




Figure 8: Hand hygiene compliance, Pasqua Hospital, Patient Care Areas, July - September, 2019




Figure 9: Hand hygiene compliance, Wascana Rehabilitation Centre, Patient Care Areas, July - September, 2019




Figure 10: Hand hygiene compliance, Regina Pioneer Village, Patient Care Areas, July – September, 2019
